Peninsula Clean Energy used EV rebate eligibility

Must be approved prior to purchase

- Be a San Mateo County resident; one incentive per household
 - For the increased incentive, residents must meet the qualifying income requirements
- 2. Purchase an eligible vehicle:
 - Used plug-in hybrid or fully electric vehicle, no more than 8 years old
 - Plug-in hybrid must have a minimum 25-mile range
 - Purchase price before incentive(s) cannot exceed \$25,000

Combine rebates for even more savings

In combination with Peninsula Clean Energy's rebate, incomequalified residents may also qualify for additional used EV incentives from regional and state programs:

Program	EV incentive amount**	Additional info
Clean Cars for All	\$5,500 – \$9,500	Must retire a vehicle 2005 or older to qualify. Limited to certain Bay Area zip codes.
Driving Clean Assistance Program	\$4,500 – \$5,000	Grant and (optional) financing assistance program. Bay Area only.
Clean Vehicle Assistance Program	\$4,500 – \$5,000	Statewide grant and (optional) financing assistance program.
