ARREST- Willful Discharge of Firearm, Child Endangerment, Possession of Firearm, & Possession of Controlled Substances for Sale

On 05/21/2024 at approximately 2:38 PM, officers and detectives responded to the area of the 2400 block of Wright Court in South San Francisco, on the report of gunshots being heard. Due to law enforcement activity and the proximity to nearby schools, the schools were asked to shelter in "Secure Campus" mode.

Through investigation it was determined to be an isolated incident that occurred at a residence on the 2400 block of Wright Court. Thirty-seven-year-old Timothy Nhok of South San Francisco was located and placed under arrest for willful discharge of a firearm and child endangerment.

Detectives executed a search warrant of Nhok's residence, subsequently locating two firearms, ammunition, and illegal narcotics. Nhok was placed under arrest for violating 29800(a)(1) PC- addict in possession of a firearm, 11351 HS- possession of narcotics for sale, 11370.1(a) HS- possession of narcotics while armed, 246.3(a) PC- willful/grossly negligent discharge of a firearm, and 273(a) PC- child endangerment. He was later booked into the San Mateo County Jail. This investigation is ongoing; anyone with information is asked to contact Detective Kerrigan at 650-877-8900 or tips@ssf.net.
