NOTICE IS HEREBY GIVEN that the Public Works Department of the City of South San Francisco, San Mateo County, California, pursuant its Open Trench Notification Process, is accepting Notices of Intent to Participate from Telecommunications Service Providers for collocating telecommunication facilities in the public right-of-way as part of the Sagebrush Engineering - Bandwidth IG Span 5 Segment 039-041 located on the following Public Streets:

San Mateo Avenue to Bayshore Boulevard

Description of Work:

This project proposes a new underground construction of approximate 13,349 feet via directional boring and trenching on San Mateo Avenue from the intersection of Tanforan Avenue to Airport Boulevard and along Airport Boulevard to Bayshore Boulevard.

In order to participate in the above referenced project, Telecommunications Service Providers must submit the attached Notice of Intent to Participate application by (10:00am on Friday, April 21, 2023) at the office of the City of South San Francisco Engineering Division at the City Hall Annex, 315 Maple Avenue, South San Francisco, California, 94080.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of Sagebrush Engineering/Bandwidth IG and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that Sagebrush Engineering/Bandwidth IG is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.
