## Description of Work:

This project proposes a new underground construction of approximate 3,000 feet via directional boring and trenching along Summerrain Drive and Aldenglen Drive.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of <u>AT&T</u> and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that <u>AT&T</u> is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.
