NOTICE IS HEREBY GIVEN that the Public Works Department of the City of South San Francisco, San Mateo County, California, pursuant its Open Trench Notification Process, is accepting Notices of Intent to Participate from Telecommunications Service Providers for collocating telecommunication facilities in the public right-of-way as part of the Intermountain Infrastructure Group Project # SAN\_BRN\_LOOP\_UG\_02\_SSF located on the following Public Streets:

Along Westborough Boulevard from Junipero Serra Boulevard to West Orange Avenue

### Description of Work:

This project proposes a new underground construction of approximately 5,000 feet with a portion of 572 feet in South San Francisco city limits with 2X2 inch SDR 11 HDPE, 2X1.25 inch SDR 11 HDPE, and 3X1.25 inch SDR 11 HDPE via directional boring and open trench, place manholes and handholes along Westborough Boulevard from Junipero Serra Boulevard to West Orange Avenue.

In order to participate in the above referenced project, Telecommunications Service Providers must submit the attached Notice of Intent to Participate application by (10:00am on Friday, April 3, 2020) at the office of the City of South San Francisco Engineering Division at the City Hall Annex, 315 Maple Avenue, South San Francisco, California, 94080.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of Intermountain Infrastructure Group and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that Intermountain Infrastructure Group is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.
