

## **Public Notice to Telecommunications Service Providers**

NOTICE IS HEREBY GIVEN that the Public Works Department of the City of South San Francisco, San Mateo County, California, pursuant its Open Trench Notification Process, is accepting Notices of Intent to Participate from Telecommunications Service Providers for collocating telecommunication facilities in the public right-of-way as part of the MTC, Inc. Project # N533133 located on the following Public Streets:

North Canal Street from 428 North Canal Street to South Linden Avenue and on South Linden Avenue.

## Description of Work:

This project proposes to build service connections to 408 and 428 North Canal Street by directional bore of 1,330 LF of conduit and add (2) 4'x4' splice manholes on North Canal Street and South Linden Avenue.

In order to participate in the above referenced project, Telecommunications Service Providers must submit the attached Notice of Intent to Participate application by (10:00am on Monday, December 23, 2019) at the office of the City of South San Francisco Engineering Division at the City Hall Annex, 315 Maple Avenue, South San Francisco, California, 94080.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of <u>Level(3) Communications</u> and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that <u>Level(3) Communications</u> is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.
