ARREST- Kidnapping, Assault to Commit Lewd Acts on a Child, False Imprisonment, & Sexual Battery

On 06/17/2024 at approximately 2:40 PM, officers and detectives responded to the area of the 900 block of Nora Way in South San Francisco, on the report of a sexual battery and kidnapping of a female juvenile. The sixteen-year-old victim was able to escape the suspect and responded to the South San Francisco Police Department to report the incident.

Through investigation, officers and detectives were able to identify the suspect as nineteen-year-old, Rupinder Singh of South San Francisco. Singh was located at his place of employment in South San Francisco a short time later and placed under arrest for violating 207(a) PC- kidnapping, 220 PC- assault to commit lewd acts on a child, 236 PC- false imprisonment, and 243.4(e)(1) PC- sexual battery.

Singh was later booked into the San Mateo County Jail. This investigation is ongoing; anyone with information is asked to contact Detectives Blake and Tvrdik at 650-877-8900 or tips@ssf.net.
